## *Lagoon Initiative Heating Up*

While summer stages around the country hummed with Shakespeare, the Indian River Land Trust set its stage for the next phase of our Lagoon Waterfront Initiative. Keeping in mind the Board's vision to *preserve* our natural resources, *protect* our scenic waterfront, and *provide* access to the river, a new opportunity emerged. IRLT acquired new property this summer for a much needed canoe and kayak launch located close to several natural areas of the Indian River Lagoon midway between the Wabasso Causeway and the Barber Bridge. This mainland property, which contains four acres of native wildlife habitat, lies alongside Quay Dock Road, a historic wagon road built in the 1890's to transport goods delivered by boat from the barrier island.

IRLT also is diligently working on two other conservation projects with a focus on protecting and

managing relatively large areas of wildlife habitat on both sides of the Indian River Lagoon. In addition, the Indian River Land Trust acquired two parcels in Winter Beach last fall that will connect to create the Toni Robinson Waterfront Trail on 40 acres of native habitat. If fully successful, these four projects will *preserve* over 200 acres of wildlife habitat, *protect* nearly two miles of frontage on the river, and *provide* access for walking, bird watching and paddling along this diverse waterway. And this is just the beginning. The Land Trust continues to map the entire Lagoon waterway in our county to identify additional environmentally sensitive waterfront parcels through a computer mapping project begun in 2009.

The stage is set, and with everyone's continued support, IRLT will be instrumental in forever protecting our Indian River Lagoon.
